Monte J. Hill President & CEO In 1951 seven Goodyear Tire and Rubber Company employees each deposited five dollars to charter Family Savings Credit Union. After 68 years, our membership has surpassed 63,000 with assets of over \$405 million.

While we have certainly grown over the past 68 years, one constant remains - our dedication to "people helping people". 2019 was in fact a year of unprecedented growth, but we do not exist to grow, our top priority will always be to serve our members and our communities.

In 2019 community outreach remained an ongoing focus. We are always proud to participate in philanthropic giving and local outreach in ways that support the credit union movement. This year we gave over \$8,000 in college scholarships to graduating high school seniors. We provided financial literacy education materials to over 2,700 students in over 40 schools in Etowah and Jackson Counties. Our employees donated over \$35,000 dollars to United Way and United Givers Associations, in addition to volunteering their personal time and resources to other amazing organizations. Our #FSCUCares campaign had another great year. We were able to spread numerous random acts of kindness throughout the communities we serve.

Over the years we have implemented many new ground-breaking features to our mobile app, and last year was no different. Updates included mobile enrollment, Interbank transfers, and card controls. Members can now control their debit cards with just a click of a button. This is not only convenient, but an efficient way to limit the chance of fraudulent transactions affecting our members. We strive to always be industry leaders with the electronic services we offer.

Family Savings is committed to helping our members "OWN" their credit score. Our staff is prepared, more than ever before, to assist our members in learning how to increase their credit score. An improved score can result in lower interest rates on loans which will save them money. One of the key ways we help our members gain the knowledge they need to improve their score is by holding Credit Boost Days at our branch locations where members can come in for a free, no obligation review of their credit report. We have many incredible stories about how our staff has been able to save member's money!






