



Official Rules Win A Trip Sweepstakes

***Win a Trip Sweepstakes Official Rules. NO PURCHASE NECESSARY TO WIN**

No purchase, card use, or establishing an account or service necessary to enter or win. A purchase or card use, will not increase your chances.

PRIZES & ODDS OF WINNING: On December 1, 2023, FSCU will randomly draw one (1) winner for the Win a Trip Sweepstakes (Sweepstakes) to receive a Travel Package valued up to \$2,500. The Travel Package is exclusive to airfare, lodging, and/or rental car for one trip with a total cost of \$2500 and will be booked through Credit Union Travel. Meals, beverages, fuel, and other travel expenses are the responsibility of the prize winner. The winner will select additional travelers, the destination, and the dates of travel. Travel must be booked through Credit Union Travel by December 31, 2024. Any funds that are not spent on airfare, lodging and rental car booked through Credit Union Travel will be forfeited. Any funds owed over the prize value will be the sole responsibility of the winner. The winner cannot substitute cash for the announced prize. If the announced prize becomes unavailable or not reasonably practical to provide, FSCU reserves the right substitute for an alternate prize of comparable value. The winner will be notified by phone or mail by December 5, 2023. Prize must be accepted by December 5, 2023, at 4:00 p.m. (CT). All taxes on prizes are the sole responsibility of the winner(s). Odds of winning are determined by the number of entries.

ELIGIBILITY: Must be 19 years of age or older to enter. This sweepstakes is conducted by Family Savings Credit Union (FSCU) and is not open to the employees or family members of employees, officers, directors, representatives, or agents of FSCU, its respective advertising and promotion agencies, or any of the respective affiliates, related entities, successors or assigns of any of the above. Business entities are not eligible to enter or win. Void where prohibited.

HOW TO ENTER: The sweepstakes begins on November 1, 2023, at 7:00 a.m. (CT) and ends on November 30, 2023, at 11:59 p.m. (CT). You will be entered into the sweepstakes upon: (i) opening a new Share Certificate of Deposit with a minimum balance of \$500, or (ii) mailing an alternate sweepstakes entry postmarked by the entry deadline of November 30, 2023. Transactions initiated with FSCU before November 1, 2023, or after November 30, 2023, do not result in entries.

To enter without opening an FSCU Share Certificate of Deposit, you may send us an alternate entry. Alternate entries must be mailed on a plain 3.5" x 5" postcard and are limited to one (1) entry per postcard mailed. The postcard must include (legibly hand printed) name, age, complete address, city, state, ZIP code, phone number (including area code), and email address (if any). No other entry methods are permitted. Limit one (1) mailed entry per address/person during the Giveaway Period. Entry must be received before November 30, 2023, at 11:59 p.m. (CT).

ENTRY DEADLINES: All entries must be received before November 30, 2023, at 11:59 p.m. (CT).

PRIZE CONDITIONS: In the event a FSCU representative determines, at his/her sole discretion based on his/her interpretation of these Official Rules, that an entrant is found to be ineligible, or if the entrant does not comply with these Official Rules, the potential winner will be disqualified and an alternate winner will be selected through a random drawing from the remaining entries. If the prize or prize notification is returned as undeliverable, this will result in disqualification, and an alternate winner will be selected. Except where prohibited by law, the winner's entry and acceptance of the prize constitutes permission for FSCU to use said winner's name in all forms of media, in perpetuity, without further compensation. Further, all winners must sign and return to FSCU a declaration of eligibility and liability publicity release.
