

# Requirements & Terms and Conditions

## **Major League Fishing Tournaments**

- Family Savings CU (FSCU) will award a \$1,000 bonus cash prize to the highest finishing angler in a 2021 Major League Fishing (MLF) Tournament who scores within the top 40 who participates in the said tournament in a boat financed with FSCU subject to the eligibility requirements below.
- FSCU will also award an additional \$1,000.00 bonus cash prize to the above angler if their personally owned vehicle that towed the boat to the participating 2021 MLF Tournament is also financed at FSCU under the name and account of the angler or a member of their immediate household.
- Official Family Savings BassBucks decal or Family Savings BassBucks logoed apparel is required to be visibly displayed on tournament fishing boat or on the contestant during the duration of the tournament.
  - Eligible Contestants
    - Any angler fishing in a 2021 MLF Tournament who owns and fishes from a boat owned by the angler currently financed by FSCU in the name and account of the angler or a member of their immediate household that finishes in the top 40. Only one award is eligible to be paid per tournament event.
    - Eligible 2021 MLF Tournaments:
      - February 16-18 | Toyota Series Central Division – Lake Guntersville
      - April 23 | Abu Garcia College Fishing – Lake Guntersville
      - April 24 | MLF High School Fishing – Lake Guntersville
      - June 26 | Phoenix Bass Fishing League – Neely Henry
    - All entrants must be a member in good standing of FSCU with a boat financed in their name or the name of another member of their immediate household to participate and are subject to verification.
    - MLF anglers must register for BassBucks Program on the FamilySavingsCU.com website prior to the commencement of a qualifying tournament and will be required to complete a W-9 form to receive a BassBucks bonus cash prize. Recipient is responsible for any and all taxes associated with the bonus award.

## **Other BassBucks Eligible Tournaments\***

### **\*Georgia Bass Trail**

- FSCU will award a \$500 bonus cash prize to the highest finishing angler in a 2021 BassBucks eligible tournament\* who scores within the top 20 who participates in the tournament in a boat owned by the angler or a member of their immediate household and is financed by FSCU and are registered with BassBucks.
- Family Savings will also award an additional \$500.00 bonus cash prize to the highest finishing angler if their personally owned towing vehicle that towed the boat to the participating qualified

tournament is also financed at FSCU under the name and account of the angler or a member of their immediate household.

- Official Family Savings BassBucks program decal or Family Savings BassBucks logoed apparel is required to be visibly displayed on tournament fishing boat, towing vehicle (if financed at FSCU) and/or on the contestant during the duration of the tournament. Decal must be provided by the Credit Union.
  - Eligible Contestants
    - Any angler fishing in a 2021 above mentioned tournament who owns and fishes from a boat owned by the angler or member of their immediate household currently financed by FSCU in the name and account of the angler or a member of their immediate household that finishes in the top 20. Only one award is eligible to be paid per tournament event.
    - All entrants must be a member in good standing of FSCU with a boat financed in their name or the name of another member of their immediate household to participate and are subject to verification.
    - Participating anglers must register for BassBucks Awards on the FamilySavingscu.com website prior to the commencement of a qualifying tournament and will be required to complete a W-9 form to receive a BassBucks prize.

All federal, state and local laws must be observed, and it is the Angler's responsibility to know these laws. All Anglers must read and agree to the program rules. Angler's submission of a program registration form through the FamilySavingsCU.com website will constitute a certification that the Angler has read, understands and agrees to abide by the terms and conditions of the Family Savings BassBucks Bonus Cash Prize program registration rules, requirements and terms & conditions.

The tournament director will submit the winning entrant confirmation directly to Family Savings Credit Union, Attn: Marketing, 711 E. Meighan Blvd, Gadsden, AL 35903 no later than 30 days after the conclusion of the tournament. Angler will be responsible for any state or federal taxes associated with the bonus cash prizes paid by FSCU and must furnish tax-payer ID numbers in compliance with IRS Rules at the time of registration.

Acceptance of prize money may affect NCAA eligibility. Prize money acceptance and any effect on NCAA or other eligibility is the sole responsibility of the Angler.

- BassBucks winning Angler and winning team agrees to have their photos taken with FSCU BassBucks check and said photos may be used for advertising purposes (including Social Media) or may be used to advertise the products and services of FSCU by any available medium. Angler(s) specifically agrees that their likeness may be used for promotional materials without compensation related to the BassBucks event for publicity relating to the event and FSCU's sponsorship of the event.
- By participating in the Family Savings Bass Bucks Bonus Cash Prize program, Angler understands and agrees that FSCU, its officers, directors, employees, agents, successors, or assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the world, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the Program, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes.
